Interested Bidders shall submit the electronic Bids through [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) to the **Office of Tadi Rural Municipality, Kharanitar, Nuwakot** on or before 12:00 hours on **19<sup>th</sup> January 2020**. Bids received after this deadline will be rejected.

5. Bids shall be opened in presence of Bidders' representatives who choose to attend on **14:00 hour on 19<sup>th</sup> January 2020** at the office of Tadi Rural Municipality, Kharanitar, Nuwakot. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security (as mentioned above) which shall be valid for minimum 30 days beyond the bid validity period.

6. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
