- The Government of Nepal (GoN) has allocated funds to Tadi Rural Municipality for Trail Bridge Program and Tadi Rural Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Short Span Trail Bridges (SSTB). Bid is open to all eligible Nepalese Bidders.
- Tadi Rural Municipality, Office of the Rural Municipal Executive, Kharanitar, Nuwakot invites sealed bids from registered fabricators for supply of fabricated steel parts for following Short Span Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
- 3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum four trail bridges within last five years and enlisted by DoLI are eligible for bidding. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLI may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.

The Bidding document, in English language will be made available to eligible bidders on the submission of written application along with the copy of company/ firm registration certificate and tax clearance certificate of FY 2074/75 from the office as mentioned in Para 2 upon payment of non- refundable fee of NRs 3,000.(NRs Three Thousand only) on or before office hour until 2075/ 12/03 within Office hours. The method of payment will be in cash. The document can be purchased by the bidder or his/ her authorized representative. For those bidders who choose to submit their bid electronically, may purchase the hard copy of the bidding document as mentioned above or may download the bidding documents for e -submission from PPMO's web site <a href="www.bolpatra.gov.np">www.bolpatra.gov.np</a>. Bidders submitting their bid electronically should deposit the cost mentioned above of the bidding document in office's Rajaswa (revenue) account as specified below and the scanned copy of (pdf format) of the bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

Documents received after this deadline shall not be accepted. Bids will be opened physically and electronically at 14:00 hours of 2075/12/04 in the presence of the bidders' representatives who choose to attend the Bid opening at Tadi Rural Municipality, Kharanitar, Nuwakot.
- 8. A pre bid meeting will be held on 2075/11/22 12:00 hours at the office as mentioned in para 2. All interested bidders are encouraged to visit the site and attend the pre bid meeting. Detail information about submission process of bid electronically (esubmission) shall be provided to all interested bidders who choose to attend this pre bid meeting.
- 9. If the last date of submission and opening falls on a government holiday then the next working day shall be considered as the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
