5. Electronic bids must be submitted to the office **Tadi Rural Municipality, Kharanitar, Nuwakot** through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 Noon on 26 February 2023**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 PM, 26 February 2023** at the office of **Tadi Rural Municipality, Kharanitar, Nuwakot**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **NRs. 1,12,000.00** deposited at Dharauti account No.: **02-133-00985850-01-9** on Agricultural Development Bank Ltd, Kharanitar branch, Nuwakot, which shall be valid for 30 days beyond the validity period of the bid.
