The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 PM, 2080/07/02 (19th October 2023)** at the office of ***Tadi Rural Municipality, Kharanitar, Nuwakot***. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **75,000.00** deposited at Dharauti account No.: 0213300985850019 on Agricultural Development Bank Ltd, Kharanitar branch, which shall be valid for 30 days beyond the validity period of the bid.
